### RULE CHANGES

At the November Floral meeting the following addition to the judging rules for natural sprays was agreed. In the section 'defects and penalties', unlike all other types there is at present no 'special points affecting natural sprays' so it was decided at the request of the Scottish Group to add the following.

The ideal natural spray should have open flowers, unopen flowers and green buds all in significant numbers. Side shoots, foliage, flowers and buds must not be removed. However, it is permitted to remove the crown bud and all growth emanating from the stem below the top of the vase.

Few open flowers	- A to X
Few unopen flowers	- A to X
Few green buds	- A to X
Disbudded pedicels	- X
Removal of growth above the top of the vase	- X

We suggest this is added immediately after the 'Special points affecting Exhibition Sprays

In addition, the following changes to the 'Regulations governing the naming of Chrysanthemums' in the register were made.

Delete rule 3 (b) (It was decided to now allow initials to be used)

Rule 3 (e) to now read 'The use of colours in the naming of seedlings is not allowed unless it is all or part of the name of a person or place'
